### **LGBTQ PROGRESS IN 2020**

Due to the public health crisis, the 2020 legislative session closed early and will tentatively reconvene in May. Learn more about the victories and progress in the pages that follow.

#### **Passed**

- SB0207/HB0206: Supports unaccompanied Minors in Need of Shelter and Supportive Services to receive services without guardian consent. Homelessness effects many LGBTQ youth in Maryland.
- SB0735/HB0081: Removes an outdated, unconstitutional law against sodomy, historically used to target LGBTQ people.
- SB633/HB541: Requires the training of Maryland Police Department about hate crimes with disproportionally effect LGBTQ people.
- SB0206/HB0242: Provides post-conviction relief to survivors of human trafficking, protecting LGBTQ people.
- SB0738/HB1120: Provides non-discrimination protections for LGBTQ people in healthcare and in benefits plans.

### Did not pass due to early adjournment

- SB0554/HB0488: Bans panic defense which is a legal strategy used in criminal court to defend violence against transgender and queer individuals.
- HB0706: Establishing Maryland Commission on LGBTQ Rights
- SB0993/HB1204: Aims to establish and inclusive school environment for all LGBTQ individuals.
- HB1010: Supports LGBTQ Seniors
- HB0427: Waives the requirement to publish name changes, which disproportionally effects LGBTQ individuals.

The 2020 Maryland Legislative Session will tentatively reconvene in May. We are paying close attention to its developments and will continue to fight for the LGBTQ-inclusive bills that did not pass at our first opportunity and their families in the 2020 legislative session. In this scorecard, you will find nonpartisan information on bills related to LGBTQ equality and how each member of the legislature voted on these bills.

### **EDUCATION AND YOUTH POLICY**

With increased access to information through the internet and social media, young people are coming out as LGBTQ or non-binary at much younger ages. Even those fortunate enough to have the love and support of their parents and guardians may find their schools to be hostile and sometimes dangerous environments, particularly in more conservative parts of the state. This year we supported two bills to support LGBTQ youth in Maryland.

#### SB207/HB206

**Unaccompanied Minors Consent** to Emergency Shelters

Based on national studies, 5% to 10% of youth identify as LGBTQ. However, the disproportionate numbers of LGBTQ youth who experience homelessness in Maryland alone, demonstrate the strong need for safe spaces like emergency shelters. Of the estimated 2,425 youth who go to sleep without a stable living situation, or the support of a family member/guardian, 40% identify at LGBTQ. These bills create more emergency shelter options for youth, giving them the necessary resources to become self-sufficient and achieve their goals.

### SB993/HB1204 The Inclusive Schools Act

Unlike other parts of Maryland law such as public accommodations, employment and fair housing, Maryland's education laws do not have codified anti-discrimination protections. The Inclusive Schools Act will codify anti-discrimination protections for all students, Pre-K-12 who are enrolled in our public schools and in schools receiving public funding. It prohibits retaliation against a student, parent, or guardian who files a complaint of discrimination. These bills ensure students who experience discrimination have a clear process by which they can file a complaint or seek a remedy without retaliation.

### SB872/HB959

**Non-Discrimination Protections** in Hospitals

Discrimination against LGBTQ people can take many forms in a healthcare setting: doctors may refuse to provide care for LGBTQ patients because of their sexual orientation or gender identity, may refuse to recognize the family of LGBTQ couples, and may use harsh or abusive language when treating them. These bills expands non-discrimination protections in hospital admissions, provision of personal care, and treatment to include sex, sexual orientation, gender identity, religion or creed, citizenship, age, physical or mental disability, genetic information, race, color, national origin of the individual, and ancestry.

### **ACCESS TO QUALITY, AFFIRMING, AND INCLUSIVE HEALTHCARE**

The Affordable Care Act went a long way to ensure that LGBTQ people had access to better care, but the law doesn't guarantee that our community will receive access to care and work remains to ensure that LGBTQ people have access to quality, affordable, inclusive, and often life-saving health care.

Discrimination against LGBTQ people can take many forms in a healthcare setting: doctors may refuse to provide care for LGBTQ patients because of their sexual orientation or gender identity, may refuse to recognize the family of LGBTQ couples, and may use harsh or abusive language when treating them. These bills ensure that hospitals and related institutions as well as people licensed or regulated by the Maryland Department of Health or Maryland Insurance Administration cannot deny services or coverage to people based on race, color, religion, sex, age, national origin, marital status, sexual orientation, gender identity, genetic information or disability of the individual.

Cultural Competency Training for Healthcare Professionals

This bill establishes cultural competency training and coursework to better serve and understand minority Marylanders, encompassing training on issues including ethnicity, religion, language, sexual orientation, and gender identity. Health care professionals who fail to complete the appropriate training or coursework will be denied renewal of their license to practice.

### CRIMINAL JUSTICE, POLICE INTERACTIONS, AND CORRECTIONS

While Baltimore City has been in the news for how its police disastrously deal with community members, the entire state has long-standing issues with how it handles people in the criminal justice system. LGBTQ individuals face extra – often dangerous – problems throughout the system.

## SB554/HB488 Prohibiting LGBT Bias Panic Defense

A panic defense is a legal strategy used in criminal court to defend violence against transgender and queer individuals. The gay and trans panic defense claims that the discovery of the victim's identity as LGBTQ was so shocking that the perpetrator could not control their rage or fear and thus acted violently. This bill would require the courts to provide jury instructions advising juries to make their decisions without improper bias or prejudice based on sexual orientation or gender identity, specify that neither non-violent sexual advances nor the discovery of a person's sexual orientation or gender are legitimate provocations for murder, and provide proactive education to courts, prosecutors, defense counsel, and the public about the gay and trans panic defenses and the secondary harm it has on the LGBTQ community.

## SB633/HB541 Police Training for Hate Crimes

In 2016, FreeState Justice conducted a Needs Assessment of LGBTQ Marylanders, surveying and conducting listening sessions with over 500 LGBTQ Marylanders to better understand barriers to full equality. We learned that almost 1 in 3 LGBTQ people consider street harassment and interactions with law enforcement to be urgent issues facing the community. These bills mandate that police officers receive training, on entry to the force and every 3 years in continuing education, to better understand how to investigate and report hate crimes.

## SB735/HB81 Repealing Sodomy Law

Anti-sodomy laws have a dark history of persecuting and marginalizing LGBTQ people, including imprisoning LGBTQ people for engaging in consensual sex and reinforcing the dark, dehumanizing myth of sexual perversion about consensual same-sex intercourse. These bills repeal the unconstitutional "Sodomy and Unnatural or Perverted Sexual Practice" law that continues to exist on Maryland's Criminal Codes. This law currently states: "A person who is convicted of sodomy is guilty of a felony and is subject to imprisonment not exceeding 10 years."

Traffickers frequently target marginalized populations and individuals with vulnerabilities. Studies have shown that LGBT homeless youth are at the highest risk for sex trafficking and sexual exploitation versus their heterosexual counterparts (58.7% vs. 33.4%). These bills would remedy significant legal gaps in existing vacatur laws by expanding the post-conviction relief available to survivors of human trafficking, including many LGBT survivors, who are already recognized as lacking the criminal intent to commit the crimes they were convicted of.

### **NAME AND GENDER CHANGE POLICIES**

While our culture continues to evolve around transgender issues, major barriers like access to changing one's name and gender on identity documents remain, putting transgender and nonbinary people at risk for discrimination in jobs, housing, travel, and schools.

### HB427 **Waiver of Publication Requirement** for Name Changes

Publication is a costly requirement that disproportionate impacts individuals with low incomes, individuals living in urban areas, and individuals who are transgender. Currently, when a transgender or non-binary person attempts to change their name or gender marker on identity documents, they are required to publish in a local newspaper. This bill will improve access to name and gender changes for Transgender and Non-Binary Marylanders by allowing them to waive the publication requirement upon request, protecting the privacy and safety of transgender Marylanders and reduce the likelihood that they will be exposed to unnecessary discrimination and violence.

### **NON-DISCRIMINATION POLICIES**

Legal equality does not mean lived equality. All too often, transgender Marylanders are denied access to restrooms and locker rooms in places of public accommodation, despite having legal protections enshrined in state law that allow the use of restrooms consistent with one's gender identity.

## Establishing a Committee on LGBTQ Affairs

This bill will create a 15 member State Commission on LGBTQ affairs to assess the challenges facing LGBTQ Communities in Maryland. It is responsible for collecting data across State agencies on the implementation of LGBTQ-inclusive policies and complaints alleging discrimination based on sexual orientation and gender identity. It will study and establish best practices for inclusion of LGBTQ individuals and communities and work with local governments to pass laws that are inclusive of LGBTQ individuals. Finally, it will publish an annual report that includes recommendations on policies for LGBTQ adults and youth that work to end discriminatory practices in the State.

### **LGBTQ Seniors Bill of Rights**

LGBTQ elders who reside in long-term care facilities, including nursing facilities, immediate care facilities, and residential care facilities for the elderly, often face discrimination and harassment. This bill protects the privacy rights of LGBTQ residents by requiring facilities to ask for their gender identity, name and pronouns. It mandates that health care facilities use visual barriers, like doors or curtains, to ensure privacy for all residents, including transgender and non-binary individuals, when they are partially or fully unclothed, and it only allows health care staff who are responsible for treatment to be present when a resident is partially or fully unclothed. Finally, residents are given the right to refuse to be examined, observed or treated by staff if the primary purpose is educational or informational without losing access to quality treatment.
